#### • CJ&D Continues to Fight for Consumers and Families

We are facing renewed attacks on the civil justice system. The major corporations and special interests that fought so virulently for Illinois' new medical liability law that caps compensation for malpractice victims have introduced a new suite of proposals to undermine our rights. Their proposals continue a dangerous trend of tipping the scales of justice in favor of defendants accused of wrongdoing. With their new bills, they aim to drive up costs to victims, reduce compensation to injured people, weaken the jury system, and throw up legal hurdles to keep legitimate suits from being filed.

• We are working hard to prevent these dangerous proposals from being a reality in Illinois. We have formed a broad coalition of labor, community, and civil rights groups to work with us in opposing this cruel agenda. We are recruiting people who have used the civil justice system to seek redress for wrongdoing to tell their story to the media, legislators, and the public. We are producing reports and fact sheets to debunk the myths of so-called "tort reform" and demonstrate the importance of the civil justice system.

• While we take on new challenges, we are continuing to educate the public about medical malpractice, putting front and center the voices and faces who are effected by them. Molly Akers from New Lenox received an unnecessary operation that left her disfigured and in constant pain. She will have the opportunity to tell her story on the learning channel next month. We are also working to expose the myths behind Illinois' new medical liability bill. The day after the bill was signed the Illinois Division of Insurance demanded that ISMIE-mutual, Illinois' malpractice insurer largest insurer, appear at hearings to investigating the company's "problematic" rate increases.
